# University of Alabama Faculty Senate Community and Legislative Affairs Committee 2020-2021 Report

This report describes the activities of the **Community and Legislative Affairs Committee**. This report updates activities since the last report submitted in May 2020.

## United Way:

Our committee supported the United Way of West Alabama's fund drive by encouraging participation in the University's fund drive. This year's fund drive was the first conducted online due to COVID-19 operating procedures. Donation cards were available by request only.

## Coat Drive Benefitting Brewer-Porch Children's Center:

## Legislative Delegation Relationships:
